please consider the following criteria.*

- Nomination forms must be completely filled out and accompanied by a separate letter of recommendation from the nominator.
- Several digital pictures of the nominee at work must be submitted with the nomination. These will be used during the awards presentation at the 47<sup>th</sup> RMLA 2018 Conference. Pictures should be E-mailed to [rmla@nsaa.org](mailto:rmla@nsaa.org) with a subject line of RMLA Awards so it will pass through the spam filters.
- The deadline for submitting nominations is **Friday March 30, 2018**.
- Nominee must have a minimum of two years/seasons of employment at your resort.
- Candidates may hold management, supervisory, foreman, lead, or apprentice positions.
- Nominations will only be accepted from superiors of the nominees.
- Candidates should represent your resorts premier Lift Operations or Lift Maintenance employee.
- Each resort may nominate only one employee for each award.
- Nominees should plan to attend this year's conference to be recognized at the awards luncheon on Wednesday, May 9, 2018
- The award winner will receive a complementary RMLA 2018 Conference registration and might be asked to help present a session.
